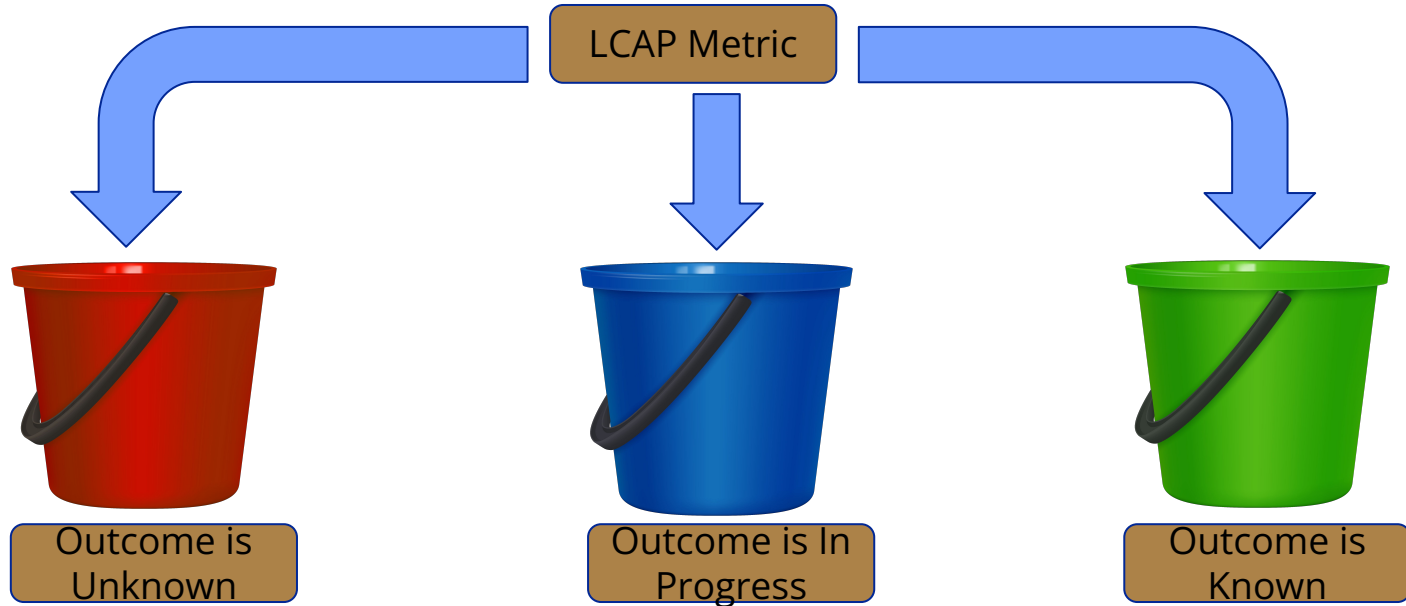

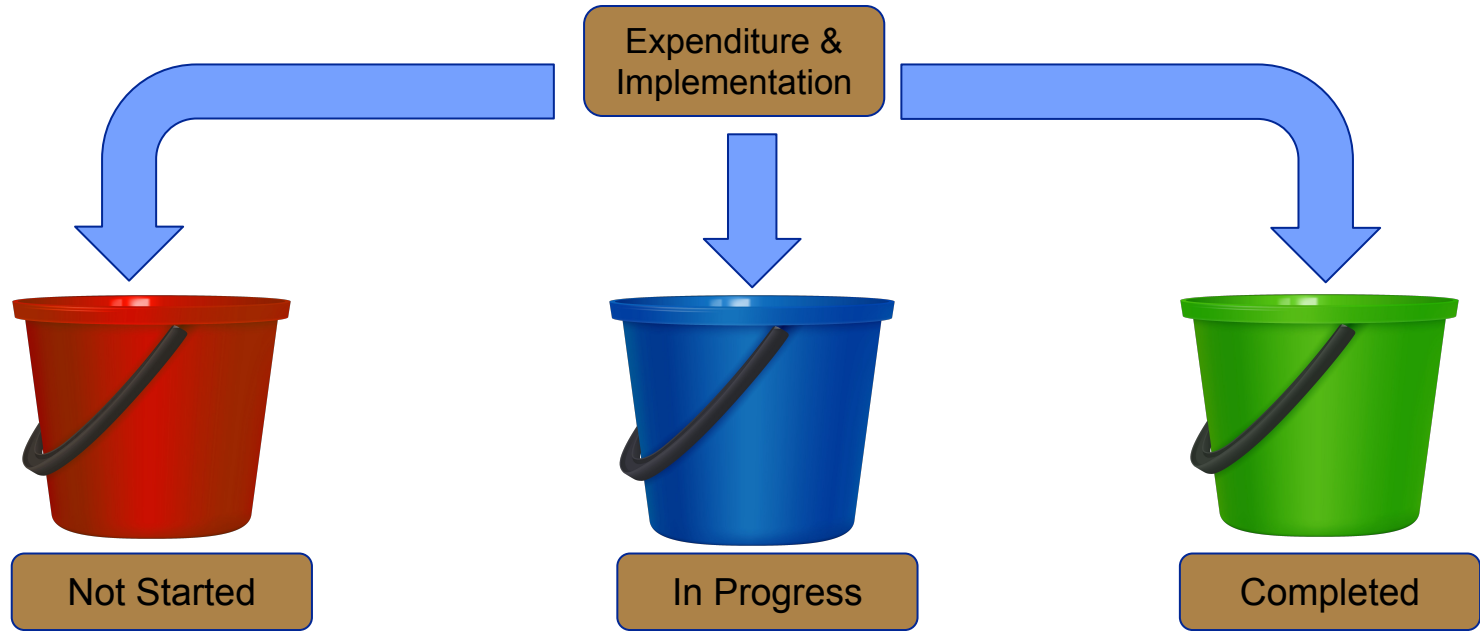
Mid-year Update: LCAP Metrics
